An article entitled "Philanthropic Fundraising in Higher Education: Alumni Engagement, Brand Equity, and Social Impact" explores the influence of alumni engagement, university brand equity, and the social impact of philanthropic institutions on alumni's philanthropic intentions towards their alma mater. The findings reveal alumni engagement (AE), brand equity (BE), and the social impact of campus philanthropic institutions (SI) significantly influence alumni philanthropic intention (PI). The study emphasize that alumni philanthropy becomes a key pillar of higher education financing in the future. Further details of the study can be found on page 1845.

Fajar Adinugraha and colleagues investigate the effectiveness of indigenous knowledgeoriented instructional modules to promote biodiversity literacy. Their study highlights the significant role of the IKIM module in improving biodiversity literacy, demonstrating its effectiveness in integrating western science and indigenous knowledge. The findings indicated that the experimental group exhibited a more pronounced enhancement in biodiversity literacy scores than the control group. The results also suggest that IKIM enhances biodiversity literacy and aids contextual efforts to mitigate its loss. Detailed information of this article is presented on page 2073.
